# SSI/SSDI Outreach, Access, and Recovery (SOAR)





#### Introduction

The MDHHS Housing and Homeless Services team, in partnership with the SOAR TA Center, is hosting quarterly SOAR training for Michigan in FY 2024. Trainings will be organized into four cohorts, A through D, with specific schedules. Training is virtual and consists of the SOAR Online Course followed by a SOAR Online Course Refresher & Michigan Fundamentals Session, as well as regular group check-ins throughout the process.

Individuals that pass the SOAR Online Course <u>and</u> complete a SOAR Online Course Review & Michigan Fundamentals Session will be designated as a Certified SOAR Practitioner in Michigan.

## **Training Highlights**

- A step-by-step explanation of the SSI/SSDI application and disability determination process.
- Strategies for working with individuals experiencing or at-risk of homelessness, and who have serious mental illness and co-occurring disorders — only a fraction of this population receives the benefits to which they are entitled.
- Exercises and worksheets provide practical application tools.
- Learn how to track outcomes of your SOAR applications in the Online Application Tracking (OAT) system.
- Understand what the SOAR process looks like in Michigan.

### **Training Expectations & Requirements**

- Individuals must intend to become a Certified Michigan SOAR Practitioner.

  SOAR practitioners will assist adults (age 18+) who are experiencing or at risk of homelessness and have serious mental illness, medical impairment, and/or a co-occurring substance use disorder to apply for Social Security Administration's disability programs, Supplemental Security Income (SSI) and Social Security Disability Insurance (SSDI).
- Individuals must complete registration with MDHHS Housing and Homeless Services to participate in a training cohort
  - o A registration link will be distributed via email prior to each training cohort.
  - Registration will include a sign-off acknowledging that the individual's employer/supervisor has agreed that SOAR activities will be allowable job duties for the individual's position.

- Individuals must pass the SOAR Online Course <u>and</u> complete a SOAR Online Course Review & Michigan Fundamentals Session in order to be designated as a Certified SOAR Practitioner in Michigan.
- Once trained it is expected that Certified SOAR Practitioners will complete at least 3 SOAR applications per year; and Maintain an initial application approval rate of at least 60%.
